- Strong customer and stakeholder management skills.
- Strong commercial awareness with experience of managing to a contract.
- Experience of managing Third Party suppliers and their associated contracts.
- Good knowledge of financial processes including project cost control and ability to interpret and report financial data and analysis.
- Excellent interpersonal skills and the ability to communicate effectively at all levels.
- Ability to work as part of a multi-disciplinary team but able to work independently and take the initiative where appropriate.

- Membership of the APM/Chartered Project Professional (ChPP) status is desirable.
- Recognised P3M qualification (Prince2, APM P, MoR, MSP), Agile experience e.g. Scrum or SaFE.
- Experience of tools including MS Project and Power BI.
